Amendment and waiver of rates from the CSO Published Tariff

Dear valued relation,

We hope this communication finds you well.

C. Steinweg Oman LLC ('CSO') wishes to inform you that, in order to support the development of the maritime services in Sohar port as well as the wellbeing of the seafarers, we have amended /clarified several rate components in our CSO Published Tariff.

The charges for barges calling our terminal, bringing vessel supplies to, and/or collecting waste from, a vessel at our berth are reduced significantly. Furthermore CSO has decided to waive the charges for shore leave for seafarers.

The amendments can be found in Annex 1, and will be applicable as from Sunday 1 October 2023 onwards.

Note 1: it is observed that not all barges calling a vessel at CSO berth are announced by the subject Vessel Agent, and are detected by CSO during terminal handling operations. CSO likes to address that each barge operation needs a HSSE assessment and needs to be registered in our terminal operating system prior to the operation, for safety and operational reasons. We like to emphasize that, as per our terms and conditions, it is an obligation for Vessel Agents to announce barges calling vessels at CSO berth in a timely manner.

Note 2: in the case of shore leave for seafarers, CSO will request the crew to leave their Seaman's Book at our Security staff, which can be collected upon returning to the terminal in order to re-enter the vessel.

#### Annex 1

Amendment 1) Article 10.3.6.4 'Supplies', will be amended as follows:

#### 10.3.6.4 Supplies to & waste collection from Vessels

### Delivery of water, foodstuffs, spare parts, fuel in trucks and/or barges, or collection of waste per barge

For all parties wanting to bring in water, bunkering (food) and/or fuel trucks to Vessels, and/or collection of waste per barge from Vessels, the following charges apply, which will be debited to the agent or relevant party:

Amendment 2) Article 10.3.6.3 'Crew Changes', will be amended as follows:

#### 10.3.6.3 Crew Changes & Shore Leave for Seafarers

Crew Changes and/or Shore Leave are allowed by the Operator for Cargo operating Vessels.

For non-Cargo operating Vessels these services will be offered on request.

For Cargo operating Vessels such crew changes / shore leaves should be executed in between berthing and prior completion of discharge/loading operations.

Note: In the case of shore leave for seafarers, CSO will request the crew to leave their Seaman's Book at our Security staff, which can be collected upon returning to the terminal in order to re-enter the vessel.

Charges for crew changes are as follows;

- a) Gate Pass Charges as per Clause 10.6.4
- b) Administrative Charges as follows:
