Section I – Ship dues (quay dues)

(Principal and recipient of invoice: ship's agent)

Ship dues are payable for the use of our quay facilities by a seagoing vessel based on the

- quantity of cargo loaded or discharged (weight dues)
- capacity and berthing time of the seagoing vessel (tonnage dues)

(1) For all services and vessels, the following **weight dues** will be charged for the

handled cargo volume over the quay € 7,00/1.000 kg

Weight dues are also payable for cargoes delivered

- from the quay into watercraft or
- from the quay by floating crane into a sea-going vessel being loaded at the quay or
- to the quay from watercraft or
- by floating crane from a sea-going vessel being discharged at the quay

a) Ship dues for goods to be discharged or loaded at dolphins and which, by order of the ship's agent, are discharged or loaded at the quay..... € 7,00/1.000 kg

Ship dues for goods to be discharged or loaded at dolphins or out-board at a quay and which are, at the request of a third party, discharged or loaded at the quay (invoice recipient: applicant) € 7,00/1.000 kg

b) When a crane is used for outboard work or for re-stowing on board, in addition to the crane hire charge (Section VIII) weight dues of € 5,75/1.000 kg

are payable on the quantity of cargo handled
(invoice recipient: applicant)

(2) a) Tonnage dues:

- minimum charge for the first 24 hours of berthing time € 0,56
- after that, for every further 12 hours of berthing time € 0,28

multiplied by the GRT* figure

* German law of 22nd January, 1975 in respect of the International Tonnage Measurement Convention of 23rd June, 1969



- b) Berthing time commences immediately after the vessel is moored at the quay. Sundays and public holidays will only be counted as berthing time if loading or discharging takes place on these days.
- c) For a vessel which berths successively **at several quays during one voyage for discharging and loading**, berthing times from mooring at the first loading/discharging berth to unmooring at the last loading/discharging berth will be counted as one continuous berthing time.

(3) Port and Terminal Security Charge

For all cargo discharged or loaded in seagoing traffic, a port and terminal security charge is payable as follows:

- Containers, loaded or empty..... € 15,00/container
- General cargo all kinds, measuring up to 5 times € 0,85/1.000 kg
- measuring more than 5 times € 1,65/1.000 kg



Section II - Cargo dues (handling charges)

(Principal and recipient of invoice: commodities agent)

A. Handling charges in List of Commodities

- (1) For handling cargo over the quay or outboard, **handling charges** will be levied with the calculation based on the rates detailed in the List of Commodities **in € per 1000 kg** of the quantity of cargo handled (providing no other basis for the calculation is laid down). For outboard handling, the agreement of C. Steinweg (Süd-West Terminal) GmbH & Co. KG must be obtained.

B. Special handling charges

- (1) Handling charges for **transit goods** delivered to C. Steinweg (Süd-West Terminal) GmbH & Co. KG, redelivered but not shipped seawards from this quay:

- for vehicles € 97,00/1.000 kg
- for goods measuring up to 5 times € 77,00/1.000 kg
- for goods measuring more than 5 times € 15,40/m³



Section III - Storage charges

- (1) Free quayside storage for **imports**: 3/three calendar days after the day of discharging from sea-going ship.

Free quayside storage for **exports**: 5/five calendar days after the cargo has been delivered.

Free quayside storage for **sea-borne transshipment goods**: 7/seven calendar days

Sea-borne transshipment goods are goods which arrive by sea and according to the Bill of Lading (through B/L or local B/L marked for transshipment or B's/L which clearly indicate forwarding by sea to another port) show that they are destined for reshipment by sea.

Diverging regulation for free quayside storage of **dangerous goods (GGV-See)**: One calendar day after first contact of quay
Dangerous good classified in classes 1 and 7 as well as tank container are excluded.

- (2) **Quayside storage charge** for goods measuring up to 5 times

after the days free of charge..... € 2,90/1,000 kg/day

for goods measuring more than 5 times..... € 4,50/1,000 kg/day

for full ISO container, € 32,00 per TEU/day

for full ISO container, dangerous goods (GGV-See), class 1 & 7..... € 130,00 per TEU/day

for full ISO container, dangerous goods (GGV-See), other classes. € 48,00 per TEU/day

- (3) Storage charge for **discharged goods** after expiration of the period of 07 days when storage charges are due: double the charges detailed in Clause (2) above.

Storage charge for **export goods** after expiration of the period of 21 days when storage charges are due: double the charges detailed in Clause (2) above.

- (4) Charge for **outdoor storage of goods and storage in a shed** where permission has been applied for and granted per month or fraction thereof : on request

The **monthly storage charge** will be calculated without the free days detailed above; the first day of storage is the date when the goods are received, the last day of storage the date they are taken away.



(5) Storage charge for **transit goods**: payable from the day of delivery and calculated by the weight of the goods; Clauses (2) and (3) above are applicable. Storage charge is also applicable for the day of cargo collection. *

(6) Trailer rental..... € 32,00/day

*If goods leave the storage area/warehouse again, they are not free of warehouse charges



Section IV – Weighing charges

(1) For the weighing of goods and the issuing of weight notes:

- a) - when several items are weighed..... € **14,80/1,000 kg**
 - minimum charge for each item weighed € **2,70/piece**
- b) - truck weighbridge empty & fully loaded € **55,00/process**

(2) For "**weighing goods during storage**":

- weighing charges as per Clause (1) above
- plus 50% of the indirect handling charges payable on the goods

(3) For the "**weighing of full container (VGM)**":

- a) - in the course of delivery by truck or railcar..... € **59,00/Container**
- b) - if handled/shipped through third-party-facilities..... € **92,00/Container**
- c) - during storage, fully accessible in storage block € **140,00/Container**
- d) - if not accessible, according item b) subject to additional
container movements (unstacking) € **41,50/move**
- e) - surcharge of 'out of gauge' container € **49,00/container**



Section V – Sorting charges

(1) Charges for sorting carried out while unloading cargo from sea-going ships:

up to 25 kilos per package	on request
up to 75 kilos per package	on request
more than 75 kilos per package	on request

(2) Expenses incurred by C. Steinweg (Süd-West Terminal) GmbH & Co. KG for all other sorting work: reimbursement in accordance with Section VIII, Clause (3)



Section VI – Minimum charges

- (1)** Minimum charge for each application where charges apply:..... € **87,00/application**
- (2)** If **several services** are requested in one application where charges apply, a minimum charge will be levied for each service, Clause (1).
- (3)** Fractions of 100 kilos, cubic metres and days will be counted as whole units.



Section VII – Special charges for quay gangs and services

(1) Surcharges payable for work done outside the normal weekday working hours Mondays to Fridays:

- a) for night shifts Mondays to Friday, per gang and shift **€ 2.270,00**
- b) for night shifts prior to pre-holiday shifts, i.e. on the days before January 1st, Easter, May 1st, Whitsun and Christmas, per gang and shift **€ 5.690,00**
- c) for 1st shifts on Saturdays, per gang and shift **€ 1.135,00**
- d) for shifts on Saturdays, Sundays and official public holidays (except for the 1st Saturday shift) per gang and shift **€ 3.015,00**
- e) for overtime Mondays to Fridays and after the 1st shifts Saturdays per gang and hour or fraction thereof **€ 335,00**
- f) for overtime after 2nd to 4th shifts on Saturdays, per gang and per hour or fraction thereof **€ 440,00**
- g) for overtime at Sundays and official public holidays, per gang and per hour or fraction thereof **€ 520,00**
- h) for pre-holiday shifts on Mon - Sat, per gang and shift **€ 905,00**
- i) early hours will be charged as overtime

The surcharges listed under a) to h) will be doubled or tripled if larger gangs have to be employed because of the special characteristics of the goods to be handled.

- (2)** charge for a **certificate** **€ 72,00**
- (3)** charge for **suspension of export goods** per application **€ 72,00**
- (4)** charge for issuing a HDS-document ("Hafendatensatz") **€ 85,00**



Section VIII - Charges for special services

- (1)** Charges for the hire of **cranes and fork-lift trucks** with the personnel of C. Steinweg (Süd-West Terminal) GmbH & Co. KG:

a) cranes (including driver)	per hour
up to 100 t capacity.....	€ 690,00
101 up to 208 t capacity.....	€ 795,00
 b) fork-lift truck (including driver)	 per hour
up to 8 t capacity.....	€ 145,00
up to 25 t capacity.....	€ 265,00
more than 25 t capacity (also valid for reachstacker).....	€ 425,00
 c) Personnel	 per hour
Hourly rates apply to full hours or fractions thereof.....	€ 85,00/hour
 (2) Hourly rates for work/manpower assessed on a time basis	 € 85,00/hour
and for waiting time	€ 640,00/shift

- (3) Marking** incl. material, but excluding use of marking plate(s)

a) accessible packages	€ 90,00/hour
b) non-accessible packages	as per outlay

Charged time will be rounded up to half hours with a **minimum charge of 1 hour**.

The rates are applicable for work done during the 1st shift (normal working hours), except weekends and holidays.



(4) Miscellaneous charges

Disposal of garbage* (no special and/or hazardous waste) per m³ € 225,00/m³
(minimum invoicing 1,00m³)

Disposal of special and/or hazardous waste* per m³ on request
(minimum invoicing 1,00m³)

* The German packaging legislation requires those responsible for packaging (manufacturers or distributors) to take back this packaging (which also includes any material for securing goods, protecting them from the effects of the weather or handling them correctly). Such packaging must be recycled. Those responsible for packaging may transfer their obligations to a third party. In case of such a transfer those responsible for the packaging must pay for its disposal for recycling purposes.

(3) Neutralization of containers..... on request

(4) Setting brackets for loading on wagons..... € 67,00/container

(5) Customs and special services for scrutiny and inspection of containers

- a) Transport to the CPA (Container Screening Center) during the
custody period, if the container is in the custody of the terminal,
including gate charges..... € 370,00/process
30 minutes waiting time included, thereafter..... € 55,00/per ½ hour
- b) Customs dispatch, transfer to a bonded warehouse..... € 310,00/container
- c) Customs dispatch, transfer from bonded warehouse
including completion of further proceedings..... on request
- d) Customs scrutiny, inspection etc. of container including
supervision and double interim movement during storage
if the container is full accessible in storage block..... € 118,00/container
- e) If not accessible, according item d) subject to additional
container movements (unstacking)..... € 41,00/move



(6) **Monitoring and Guarding** of containers containing
IMDG class 1 and 7 during storage period at our terminal..... € 220,00/container

(7) **Completion of dangerous goods data**
Manual completion or correction of missing, incomplete
or incorrect dangerous goods data..... € 85,00/per hour

Charged time will be rounded up to half hours with
a minimum charge of ½ hour.

(8) **Weighing** of containers..... according section IV

(9) **Reception/delivery** of containers.....according to LIST OF COMMODITIES
AND HANDLING CHARGES

Charges for services not mentioned are available on request.



Notes to the Tariff of Quay Handling Services

1. Party liable for payment

- (1) The ship's agent is liable to pay **ship dues** for the use of our quay-side cargo handling facilities by a sea-going vessel.
- (2) For expenditures in respect of safety regulations of ISPS-Codes of IMO a port and terminal security charge is payable by the ship's agent.
- (3) The **charge for handling cargoes** via the quay or outboard is payable:
 - a) by the issuer of the receiving note/quay order HDS ("Schiffszettel/Hafendatensatz") in the case of outgoing seaward traffic
 - b) by the recipient of the goods in the case of incoming seaward traffic

If the ship owner/ship's agent of a full-container vessel has taken responsibility to pay the handling charges for the loading of containers, the additional liability of the issuer of the quay order to pay the handling charges for loading in case of outgoing seaward traffic has a time limit. The issuer of the quay order will only be held liable in addition to the ship owner until the goods have been received by the ship.

In all other cases, the liabilities to pay the handling charges by the issuer of the quay order, as laid down in this tariff are not affected by the above mentioned time limit.

- (4) **Storage charges** are payable by the recipient in the case of discharged goods, by the issuer of the receiving note/quay order HDS ("Schiffszettel/Hafendatensatz") in the case of goods loaded and in all other cases by the applicant.
- (5) **Weighing charges** are payable by the applicant.
- (6) **Sorting charges** are payable by the applicant.
- (7) Charges for not particularly named services (**miscellaneous services**) are payable by the respective applicant.



2. Terms of payment

- (1) Charges and expenses incurred by C. Steinweg (Süd-West Terminal) GmbH & Co. KG are due **within six days** of receipt of invoice.
- (2) C. Steinweg (Süd-West Terminal) GmbH & Co. KG is entitled to demand **advance payment**.
- (3) C. Steinweg (Süd-West Terminal) GmbH & Co. KG is entitled to charge **interest on arrears of payment** at 4% above the rate of interest laid down by the European Central Bank.
- (4) An additional payment of 1.5% **Port Dues/Harbor Fund** is payable on all charges of this tariff (except storage charges). If applicable, all charges are subject to the German VAT valid at any given time.

3. Determination of weights and measures

Charges will be levied on the basis of the weights and measures shown in the accompanying documents or according to the customary average weights and measures. For goods weighed and/or measured by C. Steinweg (Süd-West Terminal) GmbH & Co. KG, the charges will be levied on the basis of the weights or measures thus established.

4. Charges for carriage of goods by the Port Railway

- (1) These price recommendations do not cover any expenses incurred by C. Steinweg (Süd-West Terminal) GmbH & Co. KG, in particular **demurrage** charged to C. Steinweg (Süd-West Terminal) GmbH & Co. KG by the respective **railway operator**.
- (2) Furthermore, these price recommendations do not include any charges incurred by the quay operator with respect to the **provision of wagons** by the respective **railway operator** inclusive Harbour Access Fee ("HZZ/Hafenzugangspauschale").

5. Basis of contracts

All contracts basing on the Recommendation for the GENERAL TERMS OF BUSINESS OF QUAY TERMINAL OPERATORS IN THE PORT OF HAMBURG (KBO), the GENERAL TERMS & CONDITIONS OF THE ASSOCIATION OF SHIPS' CARPENTERS & CARGO SECURING SPECIALISTS, the GENERAL TERMS OF BUSINESS OF THE ASSOCIATION OF GRAB COMPANIES IN HAMBURG, the GENERAL TERMS OF BUSINESS OF THE STEVEDORE'S TRADE IN HAMBURG, the GENERAL TERMS OF BUSINESS OF THE TALLYMEN'S TRADE IN HAMBURG, the GERMAN FREIGHT FORWARDERS' STANDARD TERMS & CONDITIONS (ADSp) as well as the HAMBURG TERMS OF STORAGE (HLB) – respectively latest versions, which we are pleased to provide you on request

Place of performance and jurisdiction for all claims and legal disputes arising out of the contractual relationship shall be Hamburg, governed by German law.
