### We draw your attention to the following points :

#### Packaging of goods :

- Shipping Marks : all units must be correctly identified with the customer's name at destination + supplier + POD. Otherwise, those that are not marked will be identified at the expense of the supplier/customer.
- Packaging : must be adapted to the breakbulk loading – otherwise packaging costs will be invoiced to supplier/customer.
- Stowage : must be adapted to the breakbulk loading – otherwise packaging costs will be invoiced to supplier/customer.
- **Trucks must be empty: no personal effects, tires or other items will be accepted.**
- Loading of goods subject to captain cargo agreement.

#### Documentation for customs clearance :

- Weight and volume: must be declared in accordance with goods.
- **All goods must be declared.**
- Commercial invoices must indicate HS CODES and gross weight.
- The exporter must have an EORI number and a VIES VAT number to establish customs formalities.
